- Acceptance of 9/20/2012 minutes
 - Only call BOCES if you do a true 4 quarter/15 minute periods game
- Playoff Procedures
 - See our website (NCGSOA.org)
 - Make sure to bring “GUIDE FOR OFFICIALS” sheet and rule book to each playoff game.
 - Cannot wear long pants during playoff games
 - Coaches will be encouraged to supply ball people
 - Referees will not stop clocks for ball retrieval
 - Center referees must have flags and a pump
 - Everyone should come with all colored uniforms, long & short
 - Overtime
 - 2 FULL 10 minutes (no sudden victory)
 - 5 minute break between regulation and 1st OT
 - 2 minute break between OT periods
 - Visiting/lower seeded team calls coin toss
 - Still tied
 - 2-10 minute sudden victory periods
 - 2 minute break between OT periods
 - Visiting/lower seeded team calls coin toss
 - Still tied – Kicks from the mark
 - Visiting/lower seeded team calls coin toss
 - Winner gets to choose to shoot first or last
 - Officials decide on which goal to use
 - Each team to supply a list of 5 shooters and their order
 - Anyone on the roster can be a shooter
 - Except a red carded player
 - Remaining teammates line up on field’s mid-field line
 - Shooters stay 10 yards in front of teammates
 - If still tied after 5
 - Another 5 **DIFFERENT** shooters selected
 - If still tied after 10

- Anyone can shoot/re-shoot
- Sudden victory
- No stutter step/approach allowed
 - If you see it, blow whistle immediately
 - **MUST** be retaken even if ball does not go in
