 - Only a “player-to-opponent” foul can be a direct kick. To an official is indirect kick

- Any foul committed by someone from **OFF** the field is an indirect kick at the place of the ball at the time of the foul
 - Any foul that happens **ON** the field, the restart is where the foul occurred (not where the ball was)
 - Question #29 - answer is 'A'
 - Make sure you make every effort to have the keeper face forward before permitting the penalty kick to proceed
 - Question #11 - answer is 'E'
 - Question #16 - answer is 'D'
- Dave will give everyone credit for questions #11 and #16
- Modified rules – posted on our website (NCGSOA.org)
 - Make sure you know the differences between JH rules and JV/Varsity rules
 - If a player is sent off, the player **MUST** be substituted for – they **DO NOT** play short-handed if a valid substitute is available
 - You must call BOCES if you do a 5-quarter or extended game
 - Straight 4-quarter game can play overtime
