## NCGSOA Interpretation Meeting 9/5/2012, 7:30 PM Island Trees HS

Joe Fasano called the meeting to order at 7:30 (See 2012 Rules Interpretation Meeting handouts)

- Intentional hand ball that denies a goal scoring opportunity
  - o If a non-goalie handles the ball
    - And the ball continues into the goal
      - Count the goal
      - Caution the player (yellow card)
      - Restart with kickoff
    - And the ball **<u>DOES NOT</u>** go into the goal
      - Send off the player (red card)
      - Penalty kick
  - o Try to hold your whistle on the play
    - If you blow the whistle BEFORE the ball still goes into the goal
      - No goal
      - Send off the player (red card)
      - Penalty kick
- No longer a "soft red" card
  - o A second caution (yellow card) to the same player is now a "straight" red
    - Player sent off
    - Team must play down for remainder of the game
- Unusual situation during the taking of a penalty kick
  - Causing a temporary suspension of play BEFORE the ball is touched by another player
    - No longer a drop ball restart
    - Instead, retake penalty kick
- Corner flag must be AT LEAST 5' in height
- Team rosters
  - Each team MUST submit a roster of all players, substitutes and bench personnel at least 5 minutes before game start
    - No roster do not start game
    - Rosters shall include player's number, full first and last name
    - Include additional people with team (ie. AD, trainer, scorekeeper)
- No coaching during an injury
- Before start of game (at midfield with both teams and head coaches), ask both coaches if teams are properly and legally equipped
  - o Only an answer of "yes" is acceptable
    - Do not start game if response is anything different
  - o Pre-game Sportsmanship card
    - MUST be read to both teams before every game all season
  - Shin guards
    - o MUST be age and size appropriate
      - Must be embossed with the NOCSAE label

- Exception NIKE shin guards are stamped on
- When asking coach if team is properly and legally equipped that puts liability onto coaches
  - If you want to see ask coach to have player show proper stamp on shin guard
- o If improper shin guard during play
  - Player goes off field
    - Cannot be substituted for until the next stoppage of play
    - Official on same side should check shin guards before allowing reentry
  - Coach gets first caution (yellow card)
  - Players get subsequent cautions
- Protective devices
  - Molded face mask is acceptable
    - MUST have a letter from the health care professional who authorized the mask at the site
  - o Casts with a soft recovering protection do not need a note
  - o Knee braces (unaltered) do not need a sleeve if there is no metal or sharp edges
- Referee's jurisdiction
  - o Begins 15 minutes prior to game start
  - o Ends when officials leave the confines of the field
  - Hand shake
    - Officials <u>MUST</u> stay for handshake
    - Officials to leave field TOGETHER
- Disqualified coach must be removed completely from the field of play
  - Not in stands or behind fence
  - o Players MUST stay on the bench
- Soccer nets MUST be anchored/weighted down
- Concussion Rule now called **HEAD TRAUMA** 
  - o If referee feels player has a head trauma
    - Player is sent off the field
      - Referee has right to refuse player re-entry
      - If coach continually insists on re-entering player
        - o Official can card coach first or Suspend game
    - Player is out of ALL completion for the ENTIRE day
    - Trainer is one of "the team" to deal with head trauma
  - o Send report to BOCES and Dave Poli within 24 hours
- Substitutions must come off at the half, on the bench side
