- Interpretation
 - Pre-game
 - Don't enter field until 20 minutes before game time
 - Wait for your partner before entering, if possible
 - Check field, check nets
 - Look for holes in nets
 - Make sure nets are properly anchored or weighted down
 - Approach coaches around 5 minutes before game start
 - Get rosters
 - Ask if teams are and will be properly equipped for length of game
 - Get captains together
 - Read sportsmanship card
 - Visitor calls coin toss
 - Winner chooses side or ball
 - Post-game
 - Once game is over, leave field (with partner) immediately
 - Do not stay for handshakes
 - Card reporting
 - Use form on our web site
 - Send-offs must be reported within 24 hours
 - Copy to Joe Pellechi and BOCES
 - Injury reporting
 - Use form on our web site
 - Heat index
 - See web site
 - Keep a copy in your bag
 - Know what your responsibilities are
 - Jurisdiction
 - Before game – up to school district administration
 - Once game starts – officials have jurisdiction
 - Drop ball restart
 - MUST be between two opposing players
 - Injury to goal keeper
 - Keeper must go out
 - Must have someone play keeper
 - Either a player from the field or from the bench
 - Sub from field
 - Returning keeper can only come in to the field – not the goal
 - Original keeper can only return directly to goal on a stoppage for caution or goal scored
 - Scrimmage cards and test answer sheets returned to Dave Poli
 - Next year all testing will ONLY be done on-line
